### 1. Call to Order

WHEREAS the Clubs & Space Committee has agreed to allocate \$10,000, to this budget line from our overall departmental budget

BE IT RESOLVED THAT: \$10,000 from the remaining Clubs Department budget is allocated to the 7688 budget line
